

Proud Ground saw significant progress in 2022 towards achieving its mission of providing the dream of homeownership to more working families and individuals. Proud Ground is continuing to focus on families who have experienced barriers to owning a home — most of whom are black, indigenous and people of color. We take seriously the importance of our team reflecting the people we serve and have diversified the board and staff.

During the summer of 2023 Proud Ground undertook a planned leadership transition and Dominique Merriweather assumed the role of Executive Director. We are pleased that Dominique will be leading an organization that has strong financial footing, having served more than 550 homeowners via the community land trust model.

The success of the Opening Doors initiative continues, and we have secured additional public and private investments needed to advance permanently affordable homeownership. Thanks to the generous support of our donors and jurisdictions, we are moving decidedly toward our objective to create 200 new affordable homeownership opportunities by 2026, with at least 75% of homeowners identifying as black, indigenous or people of color. Our strategic partnerships with culturally specific organizations and Habitat for Humanity (Portland Region) have been key to our progress.

With so much more to do in a city, region and state that continues to struggle with affordable housing, Proud Ground will continue the hard work of providing life-changing, stabilizing, wealth creating opportunities for families. We simply could not do this work without your support. Thank you!

## **Q** What was your first thought when you walked in the front door of your new home?

A I was consumed with utter gratefulness. I never thought homeownership would be attainable for me, so walking through the doors of my home was an amazing moment filled with gratitude for all the people who helped me on the journey and to Proud Ground for creating this life-changing opportunity for my family and me.

I remember my 3-year-old was so ecstatic. There was so much excitement to have a piece of space that was her own. I wish I had pictures of her facial expressions as she shared her imaginative ideas of what she wanted for her new room.

#### **Q** Describe how you feel about being a homeowner.


#### **Q** What do you love most about your home?


#### Q What was it like to purchase a home through Proud Ground?


